And one more point.

Ukraine supports peoples who value freedom and are truly willing to fight for it. The whole world sees what is happening in Iran, the scale of the killings and how the Iranian regime has invested heavily in spreading war and violence across the region and the world. Ukraine will not forget a single one of the thousands of “shaheds” that have struck our cities and villages, our people. We see that, on the issue of Iran, others in Europe have heard us, Ukraine, those Europeans who called for greater engagement and a more principled stance, and the Iranians themselves. The European Union has practically agreed on a decision to designate one of the main organizations of the regime in Iran as terrorist – the so-called Islamic Revolutionary Guard Corps. European procedures are

currently underway. In Ukraine, we have already adopted such a decision and designated this organization as terrorist. For us, this issue is closed. All terrorists in the world deserve the same treatment and condemnation – none should prevail. Thank you to everyone who helps protect lives! Thank you to everyone who stands with Ukraine!

Statement by the High Representative on behalf of the EU on the alignment of certain countries with Council Decision (CFSP) 2026/421 of 19 February 2026 amending Decision (CFSP) 2025/1577 updating the list of persons, groups and entities covered by Common Position 2001/931/CFSP on the application of specific measures to combat terrorism

On 19 February 2026, the Council adopted Decision (CFSP) 2026/421¹.

That Decision added one entity to the list of persons, groups and entities involved in terrorist acts and subject to restrictive measures under Common Position 2001/931/CFSP on the application of specific measures to combat terrorism².

Albania, Bosnia and Herzegovina, Iceland, Liechtenstein, Moldova (Republic of), Montenegro, North Macedonia, Serbia and Ukraine align themselves with this Council Decision.

They will ensure that their national policies conform to this Council Decision.

The European Union takes note of this commitment and welcomes it.

Head: Mohammad Pakpur – Major General, Commander-in-Chief of the IRGC from 13.06.2025, born in 1961, a native of Kyiv. Erak, Islamic Republic of Iran.

Date and place of formation: 05.05.1979, m. Tehran, Islamic Republic of Iran.

Date and number of the conclusion of the ATC Headquarters at the Security Service of Ukraine on the inclusion of the organization (group) in the List: dated 30.01.2026 No 33/2-42.

Other information: The IRGC participates in the country's commercial and business activities, controlling numerous commercial structures and affecting a wide range of Iranian sectors. Profits from this activity are directed to finance illegal operations of the IRGC, in particular support for terrorism. With the support and under the leadership of the Iranian regime, the IRGC deliberately carried out terrorist acts, involving its intelligence organization and forces of al-Quds.

Інша інформація: КВІР бере участь у комерційній та бізнес-діяльності країни, контролюючи численні комерційні структури та впливаючи на широкий спектр секторів іранської економіки. Прибутки від цієї діяльності спрямовуються на фінансування незаконних операцій КВІР, зокрема підтримку тероризму. За підтримки та під керівництвом іранського режиму КВІР свідомо здійснював терористичні акти, залучаючи свою розвідувальну організацію та сили «Аль-Кудс».
